



BYLAW NO. 435-22
A BYLAW OF THE VILLAGE OF MILO IN THE
PROVINCE OF ALBERTA TO ESTABLISH FEES,
RATES, AND CHARGES FOR SERVICES PROVIDED
BY THE VILLAGE OF MILO

WHEREAS, Section 8 of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta, 2000 and amendments thereto authorizes a Municipality, by Bylaw, to establish fees for licenses, permits and approvals, and

WHEREAS, Section 61(2) of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta, 2000 and amendments thereto authorizes a Municipality to charge fees, tolls and charges for the use of it's property, and

WHEREAS, Section 481 of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta, 2000 and amendments thereto authorizes a Municipality to establish fees payable by any person wishing to make a complaint to the Assessment Review Board, and

WHEREAS, Section 630.1 of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta, 2000 and amendments thereto authorizes a Municipality to establish fees for planning functions, and

WHEREAS, Section 6 of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta, 2000 and amendments thereto gives a Municipality natural person right, which imply the power to charge for goods and services provided,

NOW THEREFORE, THE COUNCIL OF THE VILLAGE OF MILO, DULY ASSEMBLED AND PURSUANT TO THE MUNICIPAL GOVERNMENT ACT, CHAPTER M-26-1 REVISED STATUTES ALBERTA2000 HEREBY ENACTS AS FOLLOWS:

1. **THAT** this Bylaw shall be cited as the **"2023 Rates and Fees Bylaw"**
2. **THAT** the fees and charges payable for municipal services provided to the community be charged as specified in **Schedule "A"** which is



- attached and forms part of this Bylaw.
3. **THAT** the rates specified in Schedule "A" which is attached to this Bylaw, may be modified and amended from time to time, as Council desires, through amending the Bylaw; and
 4. **THAT** this Bylaw shall come into full force and effect on **March 1st, 2023.**
